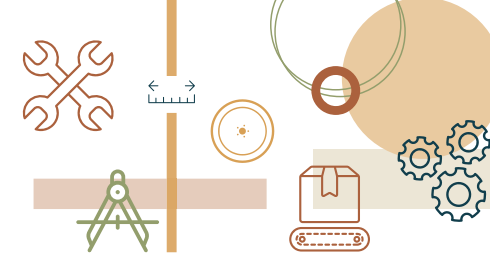

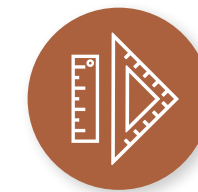

The exact duration of time will vary depending on your individual environmental conditions and thickness of each product. Generally, our fiber products will break down in less than two years.
